Congratulations to our Enabling Fund Grant Recipients!

During the first grant cycle in September 2010, Waverly Shell-Rock Jr High's Loving Stitches project received a \$900 Enabling Fund Grant. The money will be used for materials and the students will make pillow cases for terminally ill children in the hospital.

Sustainer Spotlight—Meet Terri Jackson

Terri was "thrilled" in 1980 to be invited to join Junior League and she said she was "honored to have my volunteer career placed in the spotlight!" Junior League is where Terri said that she honed her leadership skills. The organization afforded her the opportunity to network with women who had a strong sense of social responsibility and who were willing to respond to the needs of our community with courage, compassion and commitment. She said that she feels certain that describes today's members as well.

Terri's favorite quote is from George Bernard Shaw who wrote, "I am of the opinion that my life belongs to the whole community as long as I live, it is my privilege to do for it whatsoever I can. I want to be thoroughly used up when I die, for the harder I work the more I live. Life is no brief candle to me. It is a sort of splendid torch which I have got hold of for a moment, and I want to make it burn as brightly as possible before handing it on to future generations".

Speaking of future generations, Terri said that the brightest light in her life has always been family and now she and Steve are blessed with 3 great son-in-laws and 5 beautiful granddaughters. She is proud of the fact that all

three daughters have served on volunteer boards in their respective communities and she likes to think that growing up with a JL mom had a little to do with that!

Terri's words of advice to JL members would be to avoid the adjective "just" in front of the word volunteer. She said that she used to find herself explaining to others that she was "just" a volunteer – when indeed, volunteering is the most important job in the world, next to being "just a mom." Terri said, "Keep up the good work and together we will keep that torch burning brightly in the Cedar Valley."


