

Enabling Grant

The Junior League of Waterloo-Cedar Falls partnered with Tri-County Family and Child Development in September 2011 and funded them \$500 to purchase car seats. This helped to provide low income families with children ages 0-5 with appropriate car seats that are fitted correctly for the child in the vehicle by a trained and certified technician. Tri-County provides high quality family centered child development programs, strong partnerships with families and leadership and advocacy within the community for the healthy development of all young children.


Meet Sarah Pauls
